_____ I agree to keep said pet on heartworm prevention monthly and make note of dates on records.

_____ I agree to contact the rescue at any time if I am unable to continue fostering said pet, however I also understand **there is no backup plan for said animal to be transferred out of my home.** I need to make all reasonable efforts to “stay calm and figure it out” as the 3LP team consists of volunteers, not super heroes.

_____ I agree to take said animal to vet appointments and do what is necessary for the vetting process and adoption process to be a success. This may include driving to someone’s house for shots or meds, driving to someone’s house to have pictures/videos of my foster done, and arranging a meeting place for potential families to meet the animal.

_____ I agree to keep said pet indoors as a household companion, on leash while walking outside, ensure that my fence is secure, give proper fresh food and water and clean living conditions, and to protect my foster pet from any harm to the best of my ability. I will immediately notify the 3LP coordinator if I am unable to perform these duties properly.

_____ I agree to contact my foster coordinator immediately if I observe anything wrong with my foster animal so that proper vetting can be obtained. **3LP will not reimburse for care at your private veterinarian – care must be approved through your foster coordinator** at the rescue’s veterinary partner office.

_____ I agree to allow a 3LP representative to visit my home for inspection at any time.

_____ I agree to pay the full adoption fee and sign an adoption contract for my foster pet should I decide to adopt the pet, with the approval of the 3LP board. I understand adoption is not a guaranteed option for the foster.

_____ I agree to foster this animal at my own risk, and I release all 3LP members from any liability arising from damages to person(s) or property caused by this animal.

_____ I will not give said animal away or allow it to leave my possession without the approval of a 3LP representative.
